AAACESA started operations in 1994 in a time when there was a high demand for better services from bonded warehouses.

AAACESA offers the largest volume in cold rooms, cutting-edge technology, security and traceability of goods as well as the largest preliminary recognition area in order to release cargo faster and effectively, which sets our company apart.

AAACESA has a dedicated area for preliminary recognition of 3,100 m^2 inside a total surface of 13,500 m^2 and a monitoring control centre with high definition and last generation cameras. With this installed infrastructure, AAACESA is in a very high position to compete and adapt itself to the upcoming changes in the customs business area.

To guarantee cargo protection AAACESA uses both Explosive Trace Detection (ETD) and X-Ray machines to export goods, two grid value rooms with 700 m³ capacity, an internal vault with facial recognition, a strongroom and up to 80 security guards in the facility.

To speed up and handle cargo more effectively, AAACESA is currently using more than 70 forklifts of different load capacities, electric forklifts, hydraulic lifts and dollies along with over 70 slave pallets.

MONITORING AS WELL AS IN REAL-TIME TEMPERATURE TRACKING.

AAACESA offers integral services and tracking for several industries.

The company has a unique Traceability System with the ability to register in real time not merely the physical location of cargo but also the temperature it is exposed during the whole process, from the moment it's offloaded from the aeroplane, in the handling process, storage and finally its delivery in the transport units.

Automated and active evaluation of the temperature in the cold rooms is constantly overseen 24/7.

AAACESA's highly qualified staff receives training in handling and tracking of goods on an ongoing basis. They work under the most demanding excellence standards, supporting customers to guarantee the correct handling of their goods.

AAACESA was recently granted by COFEPRIS with a Health License to handle vaccines and biological products. Furthermore recognized as a reliable bonded warehouse to store medicines and other medical supplies.

Regarding the handling of pharmaceutical products, the company stands out in terms of medicines safety.

AAACESA's cold rooms are qualified and certified by external suppliers and this enables to offer a quality service for the safe storage of pharmaceuticals for both human and veterinary use.

The workforce is well trained for cargo handling in cold rooms, state-of-the-art technology, digital and analog graphic monitoring as well as in real-time temperature tracking.

Important to mention is that inside AAACESA's facilities is situated the only Government Food and Health Inspection point by SENASICA for imported goods.

Other products AAACESA handles in cold chain area perishable products such as meat and fish, dairy products, active ingredients, as well as capsules.
